Brief details of litigation viz. name(s) of the opposing party, court/ tribunal/agency where litigation is filed, brief details of dispute/litigation	Pursuant to our Letters dated June 02, 2021, August 27, 2021 and September 02, 2022, the Company had entered into a share purchase agreement ("SPA") on June 02, 2021 with the existing shareholders (i.e., Barkur Dharmaraj Shetty, B.D. Shetty HUF, Saibala Dharmaraj Shetty, Rajeshwari D Shetty, Jeenanath Dharmaraj Shetty and Balakrishna Rajiv (Barkur) Shetty) ("Sellers") of Unitop Chemicals Private Limited ("Unitop") for the acquisition of 100% of the total equity share capital (on a fully diluted basis) of Unitop, in multiple tranches, subject to completion of the conditions precedent as set out in the SPA. The Company has already acquired 80% of shares of Unitop. As per the SPA, the Company was to acquire the shares of Unitop in three tranches, as intimated to the stock exchanges on June 02, 2021. However, the Sellers have not complied with certain obligations and conditions under the SPA. Hence, the third and last tranche acquisition was not completed. In light of the above background, the Sellers have initiated an arbitration proceeding under the SPA before Mumbai Centre for International Arbitration against the Company and Unitop.
