Pursuant to Regulation 30 read with Para B of Part A of Schedule III of the Securities and Exchange Board of India ("SEBI") (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), and our intimation dated October 21, 2023 regarding the expansion of facility at Dahej, the Company has successfully commissioned the expansion of its facility at Dahej with an additional capacity of **20000 MTPA**, effective from September 26, 2025. With this commissioning, the total installed capacity of the Company stands at **152500 MTPA**.

Further, pursuant to Regulation 30(9) read with Para B of Part A of Schedule III of the Listing Regulations and our intimations dated October 19, 2023 and October 17, 2024, regarding the capacity expansion project at Unitop Chemicals Private Limited ("Unitop"), material subsidiary of the Company, we hereby submit that Unitop has successfully commissioned **15000 MTPA** ethoxylation capacity out of the total planned **30000 MTPA** expansion at its facility in Dahej, effective from September 26, 2025. With this commissioning, the total installed ethoxylation capacity of Unitop stands at **51000 MTPA**. Further, the second phase of the expansion is expected to be completed by Q3 FY26.
